**Subject:** Granting permission to new affiliation on conditional basis for first year Bachelor of Computer Application (B.C.A.) Self-financed programme from academic year 2023-24.

Dear Sir,

With respect to the above subject, it is informed to you that your institution had applied for getting new affiliation to start Bachelor of Computer Application (B.C.A.) self-financed programme from the academic year 2023-24. In this regard, the local inquiry committee was appointed by the university and has inspected the place and submitted a positive report. Academic Council and Executive Council of this university has recommended to grant new affiliation to your institution to start first year Bachelor of Computer Application (B.C.A.) Self-financed programme from the academic year 2023-24, with intake of 60 seats on the fulfilment of all conditions as given below:

- 1. All university affiliation conditions have to be fulfilled within a month on receipt of the undertaking.
- 2. Need to obtain the essential permission from the education department for this programme and have to submit the same.
- 3. No excess student shall be admitted then the intake sanctioned by the university.
- 4. According to UGC and University norms, the trust should have possession of 5 acres of non-agricultural land in the name of the trust within a year and also has to construct its own college building under the ownership of the trust within stipulated time, as per affidavit submitted.
- 5. Institute have to appoint qualified teaching and and non-teaching staff as per UGC and University norms and have to obtain the university approval for the same within a month.
- 6. Institute have to purchase Books related to the Curriculum for the library.
- 7. Institute have to register itself on AISHE portal.
- 8. Institute have to obtain NOC from the Fire Department.
- 9. Institute have to constitute Women Development Cell, SC-ST Cell, and Anti-ragging Cell.
- 10. In accordance with the circular dated 21/12/2001 and other resolution issued by the Education Department from time to time, as part of the recommendation for new affiliation the trust have to deposit a joint fixed deposit of Rs.10,00,000/- for the period of 6 years in favour of "The Registrar, Shri Govind Guru University and the President of the trust" in a nationalized bank within seven days on receipt of this letter. If the Education Department instruct any other fixed deposits will have to be mandatorily deposited at the university.

After reciveing the approval of state government further process for new affiliation shall be processed.
